**TEAM SCORING:** we have decided to score the meet as combined scoring places 1-5. There are banners that will be presented to teams in the top 1-5 on Sunday.

**MEET MOBILE:** meet mobile will be active throughout the meet and free heat sheets will also be posted through meet mobile.

**WARM UP SAFETY:** For all sessions, swimmers must utilize a "sit and slide"/"three-point" entry to enter the pool for warm-ups, by first sitting on the deck, and then sliding, feet-first, into the pool.

**SPECTATORS AREA:** Spectators are now permitted in the balcony at no cost. Part of the balcony may be restricted for swimmers.

**PARKING:** Park only in legal marked parking spots. **Illegally parked cars will be towed.** Should the parking lot at the BSI fill, there is a large overflow lot adjacent to the BSI facility.

**REGISTRATION ISSUES**: Please confirm with NE Swimming any registration issues with your swimmers by Thursday at 5:00 PM with the NE Swimming office.

**NO DECK CHAIRS ON POOL DECK:** are permitted anywhere in the facility due to space availability and safety.
