**FINANCIAL FORM & PAYMENT:** All coaches, please complete this online waiver form prior to warm up on Friday. If you have not already paid, please turn your team check and financial form in Friday at the timing table.

**SESSION BREAKDOWNS:** Check the team warm up schedule for all warm up and start times.

**SCRATCH DEADLINES:** All scratch sheets are due 30 minutes prior to the start of each session. Please pick up and turn in your scratch sheets at the control table on deck.

**SCRATCHES FROM FINALS:** Preliminary results will be announced, and swimmers will have 30 minutes to scratch or declare their intention to scratch to Admin Referee. Scratches from finals must be made in-person. Failure to compete in the finals round of a prelim/finals event, without properly scratching, will result in the swimmer being barred from all further competition for the remainder of the meet, including relays and time trials. If the swimmer has no further competition from which to be penalized, a \$100 fine will apply.

**ALL DISTANCE EVENTS:** will swim fast to slow.

**MEET MOBILE:** meet mobile will be active throughout the meet and free heat sheets will also be posted through meet mobile.

**SPECTATORS AREA:** Spectators are permitted in the balcony at no cost. Part of the balcony may be restricted for swimmers.

**PARKING:** Park only in legal marked parking spots. **Illegally parked cars will be towed.**

**REGISTRATION ISSUES:** Please confirm with NE Swimming any registration issues with your swimmers by Wednesday at 5:00 PM with the NE Swimming office.

**NO DECK CHAIRS ON POOL DECK:** are permitted anywhere in the facility due to space availability and safety.

**MEET STREAMING:** information is available on the meet webpage.

**OFFICIALS:** anyone interested in officiating may contact the meet referee prior to the meet.

**HOSPITALITY:** there will be no food allowed on deck. CRA will provide officials and coaches with hospitality area throughout the meet.

**ENTERING & EXITING POOL AREA:** Everyone is to enter the natatorium via the wet corridor. Do not have swimmers arrive more than 15 minutes before their warmup time, the pool door will be open for coaches and officials 20 minutes before each session's start of warmups.
