FINANCIAL FORM & PAYMENT: All coaches, please complete the financial form (located at the end of the meet information) with payment before warm ups on Friday. If you have not already paid, please turn your team check and form in on Friday at the timing table. NO payment and forms No swimming! Reach out with any questions, your prompt attention to this is appreciated.

SESSION BREAKDOWNS: Check the team warmup schedule for final warmups and start times.

CONDUCT OF MEET: The meet will be swum as preliminaries and finals, except for events 400 meters and longer will be swum as timed finals. All 9-10 events will be Timed Finals. For the preliminaries/final events, 11-12 will advance 1 heat to finals, 13-14 and senior events will advance two heats of 8 swimmers to finals.

PRE-MEET SCRATCHES: If you have advance individual scratches or anyone who will not be attending the meet, please email danwarner1955@gmail.com with those scratches.

SCRATCH SHEET DEADLINES- PRELIMS/TIMED FINALS: All scratch sheets will be due 30 minutes prior to the start of each session. Please pick up and turn your scratch sheets at the control table on the spectator level.

DISTANCE EVENTS: All events will swim fast to slow.

ENTRY LIMIT PER DAY: 11 & over swimmers (prelim/final) are a maximum of 3 events per day, 10 & Under swimmers (timed finals) a maximum of 6 events per day.

SWIM OFF'S: all swim off's must be resolved during prelims, swimmers and coaches should not leave the pool till confirming there are no swim offs

SCRATCHES FROM FINALS: Preliminary results will be announced, and swimmers will have 30 minutes to scratch or declare their intention to scratch to Admin Referee. Scratches from finals must be made in-person. Failure to compete in the finals round of a prelim/finals event, without properly scratching, will result in the swimmer being barred from all further competition for the remainder of the meet, including relays and time trials. If the swimmer has no further competition from which to be penalized, a \$100 fine will apply.

TIMERS & PARENT VOLUNTEER WORKERS: We are asking each team for help, please see timing assignments. Timers will meet in the wet corridor to the pool 30 minutes before the start of the session for their briefing and will then be escorted to the timing area on deck. Teams are more than welcome to rotate parents throughout the sessions for their lane responsibility, however when timer shifts have ended, they must leave the deck. If any team cannot help, please let us know by Wednesday, July 24, 2024, and we will offer those opportunities to get parents on deck to other teams.

FACILITY ENTRANCE AND EXIT: All swimmers, parents and coaches will enter and exit through the second level main entrance leading to the spectator area.

TIME UPDATES: Will be accepted until Monday, July 22, 2024 (no new entries or changes). Any NT's need to be replaced with a time.
