**TIME TRIALS:** No time trials will be offered

TIMERS & PARENT VOLUNTEER WORKERS: We are asking each team for help, please see timing assignments. Timers will meet in the wet corridor to the pool 15 minutes before the start of the session for their briefing and will then be escorted to the timing area on deck. Teams are more than welcome to rotate parents throughout the sessions for their lane responsibility, however when timer shifts have ended, they must leave the deck. ### **MEET FORMAT:**

- \*\* Distance Session will be seeded fastest to slowest alternating heats women/men heats and swimmers must provide their own timer and counter.
- \*\* 12 & Under Specialty Session all 12 & Under events will be seeded slow to fast.

**WARM UP SAFETY:** "sit and slide"/"three-point" entry will be required for all swimmers," Including in the warm up/down pool.
